ANALYSIS OF E. COLI AND ENTEROCCOCUS OF FISH OF THE ORDER OF SILURIFORMES

NOTE: DO NOT IMPLEMENT THIS NOTICE UNTIL FEBRUARY 1, 2020.

I. PURPOSE

This notice informs inspection program personnel (IPP) at official establishments and official import inspection establishments about additional microbial target (i.e., *Escherichia coli* (*E. coli*) and *Enterococcus*) results for routine samples collected for *Siluriformes* fish (hereafter referred to as "fish") and fish products as part of the National Antimicrobial Resistance Monitoring System (NARMS).

II. BACKGROUND

- A. Starting on or after February 1, 2020, fish samples, including IMPFISH_MI and EXP_FI_MIC01 samples, collected for *Salmonella* analysis will also be analyzed for *E. coli* and *Enterococcus*. There are no changes to the collection procedures of these projects; the only change is additional analyses conducted on existing samples. The *E. coli* and *Enterococcus* analyses results are non-regulatory and are for monitoring trends in antimicrobial resistance and susceptibility; products are not required to be held pending test results, and these results do not impact the acceptance of imported products.
- B. FSIS uses data from NARMS to monitor trends in antimicrobial resistance and susceptibility among enteric bacteria in food animals on a yearly basis. As a part of NARMS, fish samples routinely collected will be analyzed for *E. coli* and *Enterococcus*. Isolates from these analyses, as well as the current *Salmonella* isolates recovered, will be further analyzed for antimicrobial susceptibility. Results will be posted in the Laboratory Information Management System (LIMS)-Direct and PHIS for individual establishment access. These additional analyses will be performed at the FSIS Western Laboratory.

IV. AWARENESS MEETING WITH PLANT MANAGEMENT

Upon issuance of this notice, IPP at fish establishments are to review the information in this notice with establishment management during the next weekly meeting. IPP are to advise establishment management that the additional analyses will begin on or after February 1, 2020. Sample results from the FSIS NARMS sampling program are non-regulatory; therefore, establishments do not need to hold products.

V. SAMPLE RESULTS REPORTING

- A. Positive E. coli and Enterococcus sample results will not result in regulatory control actions for raw fish.
- B. Results of these additional targets will be posted in Laboratory Information Management System (LIMS)-Direct and PHIS.
